

## Terms of use for image material

1. The images provided can be used in compliance with these terms of use at no cost. All images are protected by copyright. The company ritterwerk GmbH (referred to in the following as ritterwerk) holds the necessary rights to the images.
  2. The transmitted image material is made available exclusively for the forms of use referred to below. ritterwerk grants a simple, unique, non-exclusive, non-transferable and limited right of use.
  3. When used by the user, the photos are only permitted to serve the purpose of a pictorial structure of ritterwerk which constitutes promotional support of ritterwerk. In this respect, ritterwerk permits the reproduction, publication and/or duplication of these images in the press and also in analogue or digital publications and media.
  4. Any use of the images for a commercial, profit-oriented purpose is excluded from the no-cost use. No images may be downloaded for such purposes.
  5. According to Art. 13 of the UrhG (German Copyright Act), upon their publication, the user is obliged to give the images the respective copyright notice. The notice must be as follows at all times: "Image: ritterwerk GmbH". This also applies to electronic publications.
  6. The user is not permitted to transfer any rights that have been assigned to him or her to third parties. S/he is not permitted to forward the images in any form or to offer them for use and/or distribution in online systems. This does not include the forwarding of the images to companies commissioned with the publication and/or duplication by the user.
  7. The user must delete the digital images that s/he downloads immediately after use. An electronic storage of image files for personal archiving purposes is not permitted. This also applies to companies commissioned for the purposes of publication or duplication by the user.
  8. Any editing, modification or manipulation of the images provided which extends beyond colour corrections, cropping or reduction, is not permitted, or is only permitted with the prior written consent of ritterwerk. Any distortion of the work protected by copyright as regards the picture, word or any other form, by subsequent photographing, falsification by drawing, photocomposing or electronic means, for instance, is not permitted. The user is responsible for the content of the text.
- The use of the images for violent or pornographic uses, or uses that are otherwise unconstitutional, is expressly prohibited by ritterwerk.
9. In particular, the media are obliged to observe the journalistic principles of the German Press Council (Press Code).
  10. The consent of ritterwerk to the use of the photographic material does not include the assurance that the persons depicted, the owners of the rights to depicted works or the holders of trademark and other industrial property rights have provided their consent to a public disclosure. The user is solely responsible for obtaining the consent of third parties which is required in individual cases. S/he must observe the personal rights, copyrights, trademark rights and other property rights of the persons, works, objects or signs that are depicted. If such rights are disregarded, the user shall alone be liable for damages to any third party.
  11. As regards all printed material published, according to Art. 25 of the German Publishing Act of 19.06.1901 (RGBl. [German Imperial Law Gazette] p. 217), ritterwerk is to be provided

with a complete specimen copy with the published image material without prompting and free of charge.

12. In the event of an infringement of the conditions of use, ritterwerk may request the user to withdraw all his or her products that include the presentation of the images at his or her own cost, and to either correct them or cease their distribution altogether. If the commercial exploitation of the images has not been agreed, the authors of the image and/or owners of the rights to the image shall be entitled to additional fees for the rights to use the image in accordance with the customary market remuneration. Furthermore, ritterwerk reserves the right to claim damages. In the case of the unauthorised use of copyrighted works, these shall in any case amount to the usual surcharge of 100% on the fee which is to be claimed.

13. ritterwerk accepts no liability whatsoever for the usability/marketability/merchantability of the images for a specific purpose.

14. Should any provision of these Terms of Use be or become invalid, this shall not affect the validity of the remaining provisions. The ineffective provision shall be replaced by a provision that is effective and comes closest to the content and purpose of the ineffective provision to the extent permitted by law.
